**DUE DATE: Submission Window: Friday, March 13, 2026 to Friday, April 17, 2026**

The Florida College System (FCS) and the Independent Colleges and Universities of Florida (ICUF) have worked together to establish a cooperative, reciprocal relationship to provide additional transfer options for our degree transfer students. In an effort to inform potential degree graduates of this additional option of continuing their postsecondary education, ICUF, the State University System and the FCS have requested a list of anticipated Associate in Science (AS), Associate in Applied Science (AAS) and Associate in Arts (AA) degree graduates for the 2026 Spring term.

We suggest that students defined as anticipated graduates be those who have earned no less than 75 percent of the total hours toward degree completion as of the end of the 2025-26 Fall term. We also recommend the list includes any student who is expected to graduate at the end of the Spring term.

This data submission is optional. However, it is in the best interest of these students if all FCS institutions participate to provide maximum opportunity for all anticipated graduates to continue their postsecondary education in a Florida higher learning institution of their choice.
